Sports and Target Shooters Eligibility and Membership of approved pistol clubs

[s 98] Weapons Act 1990 Part 4 Possession and use of weapons Current

98B Membership of approved pistol clubs

(1) *It is a condition of an approved pistol club's shooting club permit that the club must not accept a person for membership of the club unless the person submits with the person's application for membership—*

(a) if the person is not a licensee, a current statement in the approved form signed by an authorised officer that the person is a fit and proper person to hold a licence; and

(b) 2 character references from persons the person has known for at least 2 years; and

(c) a declaration that the person is a current member of other named approved shooting clubs or that the person is not a current member of any other approved shooting club.

(2) *A statement mentioned in subsection (1)(a) is current for 3 months after the day it is signed by the authorised officer.*

A person cannot apply for membership of an approved pistol club (which includes SSAA Mackay Inc.) unless the person submits with their application for club membership the following information:

If the person is not a licensee (i.e. the holder of a current Firearms Licence, Concealable Firearms Licence, or similar licence that involves firearms), a current '**Statement of Eligibility**' stating that the person is a fit and proper person to hold a firearm licence, must be obtained from Weapons Licensing Branch. This statement is current for 3 months after the day it is signed by the Authorised Officer, Weapons Licensing Branch, **and**

2 character references from persons the applicant has known for at least 2 years, **and**

A declaration from the applicant detailing whether the person has current membership of another approved shooting club/s or that the person is not a current member of any other approved shooting club.
